AWARDS PROGRAM

Since 1994, the AAOF Awards Program has contributed the following to orthodontic education and research:

- \$11.5 million in funding, primarily in support of Junior Faculty, including:
 - 225 Fellowship Awards
 - 222 Research Awards
 - Over 1,000 Gifts in Support of orthodontic residency programs
 - 80% of Junior Faculty supported by the AAOF remain in full-time academics after five years
 - Final Reports from some 400 peer-reviewed, funded proposals posted to the website, i.e., www.aaofoundation.net

Support for Junior Faculty has resulted in:

- **Publications** – over 100 articles and abstracts, most of which have been published in journals within orthodontics, but many in journals outside the specialty and the profession
- **Lectures** – scores of lectures at dental, orthodontic and at other scientific meetings as well
- **Professional advancement** – to date at the 72 graduate orthodontic residency programs in the US and Canada there are:
 - 31 Department Chairs and/or Program Directors funded while Junior Faculty
 - Numerous tenured, associate and full professor positions
 - Eighteen NIH funding recipients

Since the Awards Program began just 20 years ago, the Foundation has made tremendous strides in its mission to support orthodontic education and research, funding an aggregate of \$11.5 million, primarily for the development of junior faculty.

Additionally, the AAOF has created the Craniofacial Growth Legacy Collection Project (www.aaoflegacycollection.org), an unprecedented collaboration of major orthodontic collections to not only preserve a portion of these irreplaceable, legacy collections, but also to make these records available for academic research and clinical purposes.
