Consequently we may be interested in recognizing or remembering those esteemed colleagues who have done so much for our specialty and/or have mentored us along the way. There are, of course, many ways to accomplish this and one way is to establish an AAO Foundation [Named Award](#) in their honor or memory.

A few years ago, the AAOF Board of Directors established [Named Award](#) opportunities as follows:

- Orthodontic Faculty Development Fellowship Awards – 12
- Post-doctoral Fellowship Awards – one
- Biomedical Research Awards – 12
- Center Awards – Six

Of those 31, all but seven have been spoken for, and all those still available fall under the Biomedical Research Award funding category.

Here's what's required to establish such an award, which might be named after an individual, a small group of individuals, or an organization:

*An individual, group of individuals, or an organization may name one of the AAO Foundation Named Biomedical Research Awards (BRA) with a pledged aggregate of \$250,000, with a minimum of \$25,000 per donor, and with this \$250,000 being all new pledges, whether pledge increases, first-time pledges, or some combination.*



Again, there are only seven such [Named Awards](#) still available, and once those have all been spoken for, all offerings in all funding categories will be closed.
